






INVESTMENT OBJECTIVE

R-co Conviction Credit 12M Euro aims to outperform the 75% [capitalized ESTR index + 0.085%] + 25% Markit Iboxx € Corporates 1-3, net of management fees, over the recommended investment horizon, with a portfolio invested in the different short-term bond market opportunities. From 23 December 2008 to 2 May 2013, this fund was a fixed maturity bond fund with a 2013 maturity. Since 2 May 2013, this fund is a short-term bond fund. Risk indicators and returns published since inception for few share classes are calculated from the last management change (2 May 2013).





DISTRIBUTION BY TYPE OF BOND (%)




BREAKDOWN BY RATING (%)





Manager's comments

Rates fell sharply at the beginning of the month, with US employment figures raising fears of a more pronounced slowdown in the economy. Better data for growth and jobless claims in the United States in the following weeks mitigated this trend, including in Europe. The US 10-year ended down 13bp at 3.90% after hitting a low of 3.79%. The German 10-year ended at 2.30%, stable over the month, after reaching 2.17%. The drop was more pronounced for short-term rates, which led to a steepening of the curves.

Spreads widened by 5bp for investment grade, in a uniform movement across the entire curve: +4bp for the 1-3 year, +5bp for the 7-10 year. Only the +10-year segment underperformed the other maturities, with +8bp. The utilities and real estate sectors held up well, with +0bp and +2bp, respectively, while insurers suffered on both senior debt, +8bp, and subordinated debt, +7bp. In contrast to the market, high yield narrowed by 13bp to 377bp and gained 1.12% over the month. Investment grade credit posted a weaker performance, +0.31%, driven by its carry and slightly lower rates.

Despite a slight widening of risk premiums, performance was positive, driven by a further tightening of short-term rates and the portfolio's internal return.

Glossary

Carbon intensity

The Carbon Intensity of the portfolio is defined as the weighted sum of the carbon intensities of the underlying assets in the portfolio.

Science Based Targets initiative (SBTi)

Science Based Targets initiative is an international climate action organisation that develops standards, tools and advice that enable companies to set greenhouse gas (GHG) emission reduction targets based on climate science and what is needed to reach the target of net zero by 2050 at the latest

Target Set: Corporate targets are clearly defined and science based programmes to reduce greenhouse gas (GHG) emissions that have been reviewed and validated by SBTi. The objectives of these undertakings are expressed by temperature alignments.

Committed: Commitments represent a company's intention to develop objectives and submit them for validation within 24 months. These companies do not yet have targets validated by SBTi.

Solutions: a company that provides products or services that are expected to benefit from the transition to a low-carbon economy (e.g. renewable energy power producers).






