





NET EXPOSURE BY SECTOR (%)






NET EXPOSURE BY GEOGRAPHICAL REGION (%)








NET EXPOSURE BY GEOGRAPHICAL REGION (%)

Glossary

Carbon intensity

The Carbon Intensity of the portfolio is defined as the weighted sum of the carbon intensities of the underlying assets in the portfolio.

Emissions reduction target

If a company has a target for reducing its carbon emissions, this indicator assesses the commitment to that target. Category "transition to a low carbon economy"






