



## ASSET CLASS EXPOSURE (%)




#### **SECTOR EXPOSURE (%)**

#### **BREAKDOWN BY COUNTRY (%)**






## **BEST CONTRIBUTIONS BY ASSET (%)**




## **BEST CONTRIBUTIONS BY SECTOR (%)**

Solutions: a company that provides products or services that are expected to benefit from the transition to a low-carbon economy (e.g. renewable energy power producers).




